**FOR: Spring 2022 Programs** 

## FINANCIAL OBJECTIVE AND JUSTIFICATION STATEMENT

Financial objectives vary among cost centers or program areas. In general, fees are calculated to cover the direct cost of the program with a pre-determined minimum number of participants and then increased 20% to cover administrative costs. Program fees are recalculated each time they are offered to account for any changes in costs. We also consider price breaks, competition, and what the market will bear when establishing program fees.

### PROJECTED RESULTS / OUTCOME:

Spring programs are held March-May. During the spring of 2021, we offered 227 fee-based programs and collected \$41,283.70 in revenue. This spring we will offer 141 fee-based programs and revenues may be impacted by pandemic restrictions. There are fewer programs offered in the 2022 Spring Fun Times due to the absence of summer camps. With many unknowns about the effect of the ongoing pandemic, we promote those programs in the online version of the Day Camp/Youth Summer Brochure.

Since the approval of the Children's Brochure on March 12, 2020, the City of Fort Wayne has been greatly impacted by the COVID 19 virus. These impacts have been felt throughout the summer and expect them to continue well into 2022. As a result, we may have programs and activities listed in the Spring Fun Times that may need to be modified or canceled. We hope that we can run the majority of the programs listed in the publication with appropriate safety precautions.

We are asking for the Board of Park Commissioners' approval of the Spring Fun Times as presented. To be responsive to changing directives from Governor Holcomb, Allen County Board of Health, and administrative directives from the City of Fort Wayne in this COVID 19 pandemic, and continue to serve the needs of the Fort Wayne community, we ask for the Board of Park Commissioners approval for the authority to modify, adjust and add programs (and their associated fees if applicable) until May 31, 2022, with written approval from the Deputy Director or Director.
