#### **Change Order Approval Request**

#### Scope of Work:

Park staff is requesting a Change Order for \$152,000 for the Franke Park Renaissance – Phase One project. Phase I includes the following general components:

- 1. New entrance into Franke Park from Goshen Avenue
- 2. New multi-use rentable pavilion
- 3. Connection from the new Goshen Avenue entry to the existing vehicular and pedestrian circulation system
- 4. Removal of all maintenance facilities impacted by proposed new construction

Design Collaborative was chosen as the designer for this project after a competitive RFP process. In June of 2021, the City Council and Board of Park Commissioners approved a \$996,000.00 contract.

#### **Board Approval:**

We are now requesting approval for a Change Order with Design Collaborative for \$152,000.00, which brings the total contract to \$1,148,000.00. This Change Order is the result of an <u>expanded scope of work made necessary by discoveries in the field during the inventory and analysis phase of design</u>.

The Fort Wayne Parks and Recreation and the Board of Park Commissioners met to host their regularly scheduled monthly Board meeting on July 14, 2022, to approve the above-referenced project and change the order, in the amount of \$152,000.
