### **Project Approval Request**

Original Scope of Work:

Work included, but was not limited to, excavation, drainage, milling, paving, striping, erosion control measures, and seeding to parking lots, drives, and trails at locations in Franke Park, Franke Park Zoo parking lot, Kreager Park, Downtown Community Center, Swinney Park West, and Hamilton Park.

We have multiple changes for this paving project. These changes include;

•	Contingency Allowance	\$10,000,00
	Franke Park parking lot failed inlet replacement and paying	Add \$3 500 00
•	Franke Park road full-depth asphalt repair	Add \$4 500 00
•	Franke Park road asphalt overlay near drainage structures	Add \$2,000,00
•	Franke Park road striping	Add \$300 00
•	Kreager Park trail asphalt overlay	Add \$1,000,00
•	Foellinger Theatre parking lot failed inlet replacement and paving	Add \$4,750.00

The summation of these changes increases the contract to \$6,050.00, with the funds to come out of the Parks Cumulative Capital Funds.
