SHOWCASE

AHU-1N OA:

2 OF 9 fins do not move, in looking at these, there is 2 links that have rusted and need to be replace, as well as the control rod. The damper was installed to close to louver, damper opens about ¾ of the way. The only thing to do is take all screws and anchors out and move damper back away from louver and resecure. The damper motors will need to be remounted and operation tested.

AHU-2N OA:

1 OF 9 Fins does not move, in looking at this, there is 1 link that has rusted and needs to be replaced as well as the control rod. As for bird screen, the damper was installed to close to the louver, so the damper only opens about ¾ of the way. The only thing to do is take all the screws and anchors out and move damper back away from louver and resecure. The damper motors will need to be remounted and operation tested.

AHU-3N OA:

4 OF 9 fins are broken. In looking at these, there are 2 linkages that have rusted and need to be replaced as well as the control rod.

TROPICAL

AHU-5N/6N OA

Damper will not open due to being installed to close to louver. The screws and anchors will have to be removed, and the damper moved back away from louver and resecure. Also seal gap across the top with metal. The damper motors will need to be remounted and operation tested.

AHU-7N OA

Damper opens all the way, just install metal strip on bottom side of louver.

AHU-8N OA

Damper opens all the way, just install metal strip on bottom side of louver.

WEST EXHAUST FAN DAMPER

Remove 36"x 36"broken damper. Provide and install new damper.

(THIS WILL HAVE TO BE DONE FROM THE INSIDE, THE EXHAUST FAN WIRING WILL HAVE TO BE DICONNECTED, AS TO TAKE THE EXHAUST FAN OUT TO REPLACE THE DAMAGED DAMPER)

ARID

AHU-9N OA / AHU-10 OA / AHU-11N OA

The dampers were installed to close to the louvers, they only open ¾ of the way. The screws and anchors will have to be removed, and the dampers pulled back away from louvers and resecure. The damper motors will need to be remounted and operation tested.

We will also install a metal strip at the bottom of all three louvers and clean the bird screens.

Total cost for the above is \$31,213.00

Original Scope of Work:

This project aimed to reconcile ongoing miscommunications and failures of existing controllers and sensors used to control the HVAC system at the Botanical Conservatory.

The project change includes;

• Deletion of controls for one exhaust fan and damper on the east and west ends of the Tropical and Arid houses (a total of 4 exhaust fans and dampers) and the provision of a lift to access the dampers on the east and west ends of the Showcase house. Deduct \$1,800.00

The summation of these changes results in a credit and decreases the contract amount by \$1,800.00.
