WITNESSETH: That for one Dollar (\$1.00) and other good and valuable considerations in hand paid, the receipt and sufficiency of which Grantor hereby acknowledges, Grantor does hereby grant and convey to Grantee a right-of-way and easement for the construction, operation, use, maintenance, repair, renewal and removal of a line or lines of underground facilities and equipment for the transmission of electrical energy and for communication purposes, including the right to permit attachments of others to said facilities, in, on, along, under, over, across and through the following described Premises situated in Section 22, Wayne Township, Township 30 North, Range 12 East, Allen County, Indiana, to wit: Being the same (or a part of the same) property conveyed to the Board of Park Commissioners of the City of Fort Wayne, Parcel# 02-1222-126-001.000-074, as shown as part of Richardsville Reserve East of the St. Mary's River, per plat thereof, as recorded September 10, 1845 in Deed Record F, page 481, in the office of the Recorder of Allen County, Indiana, to which reference is made for further description.

Strips of land 20 feet in width, as shown on sketch SK-030923-RW2, attached hereto and hereby made a part of this document. All parties having a copy of said sketch.

TOGETHER with the right of ingress and egress to, from and over said Premises, and also the right to cut or trim and/or remove any trees or bushes which may endanger the safety or interfere with the construction and use of said facilities.

Grantee shall promptly repair or replace all physical damage on the Premises proximately caused by the construction, operation and maintenance of Grantee's Facilities.

The Grantor warrants that no structure or building shall be erected upon said easement.

After the completion of said system, the Grantor reserves the full use of the land which is not inconsistent with the existence and maintenance of said facilities but does agree not to change elevation or grade within the area of said easement without the written prior consent of Grantee.
It is agreed that the foregoing is the entire contract between the parties hereto, and that this written agreement is complete in all its terms and provisions and shall be binding on their respective representatives, heirs, successors and assigns.
