Brewer Park Playground Equipment Project: 2023007 Project Approval Request

Scope of Work:

This project for Brewer Park consists of direct purchase of playground equipment via Sourcewell cooperative purchasing. The equipment includes two composite structures with multiple play features on each for age ranges 2-5 and 5-12 years old. Freestanding swings are included for an adjacent play area, and shade structures are incorporated into the overall design.

The cooperative pricing was received on behalf of the Board of Park Commissioners on May 1, 2024, and Landscape Structures, Inc. is the chosen manufacturer of the equipment.

Board Approval:

At this time, I would like to request approval for a contract with Landscape Structures, Inc. at a total cost of \$232,675.83, with the funding to come out of the ARPA (American Rescue Plan Act) Funds.
