<u>Truck 12.</u> 2006 Ford F250 utility truck. Acquisition cost: \$23,822. Current odometer reading is 84,893 miles.

Originally assigned to facilities as a cleaning route truck. The bed from this truck was removed to be installed on a 2022 Ford F250 that is replacing this vehicle. The truck has problems staying running, has reoccurring electrical issues, and is beyond economic repair. To be sent to auction.



<u>Truck 23.</u> 2006 Ford F250 utility truck. Acquisition cost: \$23,822. Current odometer reading is 108,944 miles.

Originally assigned to facilities as a cleaning route truck. The bed from this truck was removed to be installed on a 2022 Ford F250 that is replacing this vehicle. The truck has over 100,000 miles, has reoccurring electrical issues, and is beyond economic repair. To be sent to auction.

Truck 52, 2006 Ford F250 utility truck. Acquisition cost: \$23,822. Current odometer reading is 102,278 miles.



<u>Truck 52</u>. Originally assigned to facilities as a cleaning route truck. The bed from this truck was removed to be installed on a 2022 Ford F250 that is replacing this vehicle. The truck has over 100,000 miles, has drivability issues, and is beyond economic repair. To be sent to auction.



<u>Truck 64</u>. 1995 Chevrolet 1500 pickup truck. Acquisition cost: \$12,500. Current odometer reading is 80,587 miles.

Assigned to the zoo. This truck is nearly 30 years old and has significant rust issues along with drivability problems. The dash has stopped working and there are various other issues with this vehicle. It is beyond economic repair. To be sent to auction.



SUV 130. 2010 Ford Escape. Acquisition cost: \$14,900. Current odometer reading is 73,816 miles.

Originally assigned to Project Administration. This SUV was taken out of service in November of 2023 when it was determined that the frame of the vehicle was cracked making it unsafe to drive. This SUV was purchased used in 2014 and it is too costly to repair a damaged frame on a 14-year-old vehicle. It is beyond economic repair and will be sent to auction.
