Scope of Work:

This is a request for approval of an amended contract with our Construction Manager as Constructor (CMc), Hagerman Inc., for construction services for Riverfront Phase IIb Project. The CMc will enter into an amended contract to serve as the construction manager during the construction of the Project. The CMc will assume the risk of delivering the Project through a Guaranteed Maximum Price (GMP) contract. The CMc will be responsible for construction means and methods, and collaborated with Fort Wayne Parks to determine prequalified subcontractors to solicit bids from prequalified subcontractors to perform the work.
