Vesey Park Construction Easement Memorandum of Understanding

Project Approval Request

Scope of Work:

This request is for approval of a temporary construction easement for all work associated with demolition and/or construction made necessary by changes to electrical transmission and distribution poles and lines in and adjacent to Vesey Park.

Board Approval/Summary:

Park staff has evaluated the attached Memorandum of Understanding (MOU), including a temporary construction easement request, drafted by the Indiana Michigan Power Company, between said company and Fort Wayne Parks and Recreation. We believe this easement and the associated work is necessary, appropriate, and best serves the needs of the public.

Fort Wayne Parks and Recreation will not be responsible for any funding associated with this easement, nor will we require payment for the proposed easement.

The MOU defines responsibilities associated with any damages to the property that may occur as a result of access and/or construction activities, and includes a graphic illustrating the extent of impacts within Vesey Park.
