Truck 42, 2006 Ford F250 Route truck. Acquisition cost: \$23,822. Current odometer reading is 73,016 miles.



Truck 42. This vehicle was assigned to the facilities crew for a cleaning route. The bed was removed and installed on a new chassis. The old chassis has rust and mechanical issues and is not worth saving without a truck bed. To be sent to auction.

Truck 62, 2006 Ford F250 Route truck. Acquisition cost: \$23,822. Current odometer reading is 100,249 miles.



Truck 62. This vehicle was assigned to the facilities crew for a cleaning route. The bed was removed and installed on a new chassis. The old chassis has high mileage and rust issues and is not worth saving without a truck bed. To be sent to auction.

SUV 133, 2013 Ford Escape. Acquisition cost: \$18,200. Current odometer reading is 71,380 miles.



SUV 133. Originally assigned to the Superintendent of maintenance. This SUV suffered catastrophic engine failure when a timing belt failure caused internal engine damage. The engine would need to be replaced or rebuilt which would be more than the value of the vehicle. To be sent to auction.

Van 44, 2011 Freightliner Sprinter 2500 Van. Acquisition cost: \$37,665. Current odometer reading is 33,292 miles.



Van 44. Assigned to the Headwaters Park. This van was slated to go to auction several years ago but was reactivated when new Headwaters Park staff was hired and additional vehicles were needed. That staff now has a new replacement van and this unit is surplus. It has reliability issues and is the only Freightliner in the fleet requiring the garage to stock unique parts for it. To be sent to auction.

Golf Cart 1109, 2017 Cruise Cart M2SB6 Electric Utility Cart. Acquisition cost: \$10,242.



Golf Cart 1109. Assigned to Grounds Maintenance. This electric golf cart suffered a failure to the computer that controls the charging and output of the electrical system. The company who originally sold the cart to the city is no longer in business and parts are unavailable. This cart has been replaced by a reliable Club Car utility cart. To be sent to auction.
